It is also available as a dicamba tank-mix option in soybeans, expanding the choices for weed resistance management.

USE RATES

Apply BroadAxe XC at 25 – 28 fl oz/A.
Refer to the label, as rates vary based on Soil Texture and percent Organic Matter.
