PRODUCT INFORMATION

Vibrance CST is a broad-spectrum seed treatment fungicide containing four active ingredients: Azoxystrobin, Fludioxonil, Mefenoxam, and Sedaxane. All four of these active ingredients have a different mode of action against fungal pathogens. Vibrance CST protects cotton against damage from the Seedling Disease Complex: Damping-off, Seedling Blight, Seed Rot, and Root Rot caused by *Fusarium* species, *Pythium* species, and *Rhizoctonia* species.

Azoxystrobin is active against *Rhizoctonia* species causing seedling damping-off and *Pythium* species causing seedling blight in cotton.

Fludioxonil is active against *Fusarium* and *Rhizoctonia* species in cotton.

Mefenoxam is active against *Pythium* species causing damping-off and seed rot in cotton.

Sedaxane is active against *Rhizoctonia* species causing seed decay, seedling blight and damping-off in cotton.

Vibrance CST contains mefenoxam, a Group 4 fungicide; sedaxane, a Group 7 fungicide; azoxystrobin, a Group 11 fungicide; and fludioxonil, a Group 12 fungicide. Mefenoxam belongs to the phenylamide class of chemistry which interferes with fungal RNA synthesis. Sedaxane is a succinate dehydrogenase inhibitor (SDHI) and belongs to the carboxamide class of chemistry which disrupts cellular respiration and energy generation. Azoxystrobin belongs to the strobilurin class of chemistry which disrupts cellular respiration and energy generation. Fludioxonil belongs to the phenylpyrrole class of chemistry which interferes with osmotic signal transduction.

Fungal populations may contain individuals naturally resistant to Group 4, 7, 11, or 12 fungicides and if used repeatedly in the same fields, then resistant members may eventually dominate the population. Because resistance development cannot be predicted, the use of this product should conform to sound resistance management strategies such as alternation with fungicides with a different mode of action and/or tank mixes established for the crop and use area.

MIXING PROCEDURES

Important: Always re-circulate Vibrance CST thoroughly before using.

Follow the manufacturer's application instructions for the seed treatment equipment being used.

Apply Vibrance CST as a water-based slurry utilizing standard slurry seed treatment equipment which provides uniform seed coverage. Uneven or incomplete seed coverage may not give the desired level of disease control. Thoroughly mix the specified amount of Vibrance CST into the required amount of water or liquid inoculant for the slurry treater and dilution rate to be used.

Certain crops require addition of inoculants when the seed is treated or planted. Vibrance CST is compatible with several liquid inoculant products. Consult the maker of the inoculant product and a Syngenta representative for directions before applying Vibrance CST with inoculants.

The total application volume must be sufficient to provide desired level of coverage. Dilution is typically done with water or liquid inoculants.

Continuous agitation or mixing of the slurry mixture is necessary to prevent settling out of the solution. Clean out any unused product from the treater after treating or maintain constant agitation if the leftover slurry will be maintained overnight.
